WI-CARH SCHOLARSHIP APPLICATION

2021 SCHOLARSHIP INSTRUCTIONS

SCHOLARSHIP: There will be one scholarship awarded in the amount of Five Hundred Dollars (\$500) to a high school student or adult wishing to further their education.

BASIC INSTRUCTIONS:

1. Applications shall be printed and/or typed.
2. Submit only complete applications. Incomplete applications may not be considered.
3. Include all supporting documents including transcripts; list of references; etc.
4. **APPLICATION DEADLINE is May 31, 2021.** Applications may be submitted on or before the deadline either electronically or by mail.

PROGRAM REQUIREMENTS:

1. Applicant must be a candidate for high school graduation or a high school graduate or earned a high school diploma or equivalent.
2. Applicant must be attending or plan to attend any two (2) year or higher accredited Public or Private institution in the State of Wisconsin offering an associate or undergraduate degree OR a vocational/technical program.
3. Applicant must meet full-time student requirements as defined by having 12 or more credits per semester OR part-time student requirements as defined by having 6 or more credits per semester.
4. Applicant must have a Cumulative Grade Point Average of 2.75 or higher. A transcript of grades shall be provided with this application.
5. Applicant must submit an essay (1 page) on "My Career Goals" with this application.
6. Applicant must provide with this application two non-related references from community member/leader, teacher/administrator, and/or employer.
7. Applicant must provide certification from the WI-CARH Member Housing that he/she is a current resident in good standing if this is applicable as members will be given preference. (See #2 on General Information page.)
8. Applicant must verify that they will be attending an educational institution in the upcoming semester (i.e., Letter of Intent or registration documentation).

WI-CARH SCHOLARSHIP APPLICATION

GENERAL INFORMATION

1. Applicant must be a graduating high school senior or be currently enrolled at any two year or higher accredited public or private institution in the State of Wisconsin offering an associate or undergraduate degree OR a vocational/technical program. Previous scholarship recipients may reapply.
2. Applicant must reside in a property in Wisconsin which is part of a USDA Rural Development program. Preference will be given to applicants residing in apartment complexes which are members of WI-CARH. Resident applicants must submit verification from the WI-CARH member that the applicant is a resident in good standing.
3. Scholarships will not be awarded to employees or affiliates of WI-CARH or employees or affiliates of the member apartment complexes unless employee meets all of the criteria listed in Item 2 above.
4. Funds are to be utilized beginning with the 2021/2022 school year.
5. The applications will be judged on academic achievements, work performance, career goals, and extra-curricular school and community activities and achievements will also be considered. Success in core curriculum courses will have a bearing on the weight given to academic achievements. The WI-CARH board will have the final approval of all applicants. The WI-CARH Board or its designee may choose to interview the applicants.
6. The scholarship recipient will be notified on or before June 30, 2021 and awarded the scholarship thereafter. The scholarship recipient will be recognized at the WI-CARH annual meeting in Wisconsin Dells on October 28, 2021.
7. The scholarship will be administered by the institution attended by the recipient. Funds may be used for tuition, program fees, books or supplies for one year or longer if approved by WI-CARH. Recipient's failure to continue required course of study will cause the unused portion of funds to revert back to WI-CARH.
